## 2009 – COP 9 Argentina

- **SPC participated in COP 9 in Argentina**
  - \* was instrumental in getting the Pacific participants to fight for recognition within the Regional Implementation Annex of Asia.
  
- **Many meetings raising this same issue**
  - \* Seeking official guidance from OLA
  - \* Officially we cannot change the name of the Regional Annex as it is set in the Convention text.

# Experience with UNCCD

- 
- Common issues with other countries in Asia – speak from a combined voice of the whole Group
    - \* e.g. capacity gaps/building, need for further resources and support for reporting and implementation, mapping of land degradation etc.
  - Where there is a specific issue that is particular to the Pacific, it is possible to speak formally on behalf of Pacific Island States – if this is agreed and coordinated
    - Roles within UNCCD
      - ❖ Delegate to
      - ❖ Pacific and AP, VP Bureau positions
      - ❖ Negotiator

# Lessons Learnt

- **Consistent representation**
- **Active Participation in meetings**
- **Learn about your Convention, its institutional bodies, how they work together, their individual mandates**
  - ❖ What you can and can't ask them to do
- **Learn about the issues and if/how they affect your country/sub region**
- **ENGLISH!! esp. grammar and the use of negotiation words.**

- **Understand that as the Country Parties, you are the decision makers of the Convention that tell the Secretariats how to operate, in which areas, and within what budget**
  - ❖ once you have all fought amongst yourselves to agree on text!
