YOU WILL FIND THAT THE DIARY HAS A SEPARATE PAGE FOR EACH DAY OF THE NEXT SEVEN DAYS. SO THAT NOTHING IS MISSED PLEASE WRITE DOWN EVERY PURCHASE ON THE SAME DAY YOU BUY IT.
